The Board reviewed correspondence from a homeowner on Via Espiritu requesting stating the Carrotwood tree located in their front yard has damaged the concrete as the roots from the tree are causing it to lift. Motioned, Seconded: "To deny the request to repair the concrete walkway as the Carrotwood is located in the owners front yard and is not the associations responsibility." **Denied: 3-0**

The Board appointed Ashly Fox as the point of contact for legal counsel.
