OLD BUSINESS

<u>Inclinometer Reading:</u> Management informed the Board that American Geotechnical was able to find the inclinometer and has taken base line readings but will need to come back in November to take another reading as the new baseline has been established.

<u>Low Wattage Bulbs for Street Lamps:</u> Management provided the Board correspondence from SDGE that they will be able to provide lower wattage for our current street lamps within the next two (2) years for energy efficient lighting.

<u>Vista Pacifica HOA- Response Backflow Issue:</u> Management informed the Board that the neighboring HOA will permit the removal of the Pine tree affecting Villagio's backflows located on Vista Pacifica to be paid for by Villagio I and to pay for the installation of a replacement tree. Tabled

<u>Speed Hump Installation 740/738 Via Otono</u>: Management provided the Board bids to be reviewed. The Board directed Management to have this reviewed next year.

<u>Street Sealing / Red Curb:</u> Management provided the Board bids to be reviewed. The Board directed Management to have this reviewed next year.
